# **Recommended Actions:** That the Board of Supervisors:

- A) Approve, ratify and authorize the chair to execute the Second Amendment to the Agreement for Services of Independent Contractor with **Aurora Vista Del Mar Hospital** (not a local vendor), for the provision additional of Acute Inpatient Services, to increase the FY 16-17 total contract amount by \$250,000 to cover unanticipated increased demand, and to extend the contract by one month into FY 17-18 for a projected additional \$250,000, for a new total contract amount not to exceed **\$2,724,000** through July 31, 2017.
- B) Determine that the above actions are government fiscal activities or funding mechanisms which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment, and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA guidelines.

### **Summary Text:**

The Department of Behavioral Wellness provides a continuum of mental health and substance use disorders to Santa Barbara County residents, in part through contracted providers including Community-Based Organizations (CBOs). Contracts with facilities providing services at various levels of care are

key to ensuring that the needs of clients are optimally met. Due to an increased demand for inpatient contracted beds, Behavioral Wellness needs to amend its contract with Aurora Vista Del Mar Hospital (AVDM). In May, 2017, the Board of Supervisors approved a budget expansion that increased the funding for Inpatient Hospital Costs by \$700,000. Approval of the current recommended actions will allow Behavioral Wellness to cover unanticipated additional services provided by AVDM during FY 16-17, and to cover the first month of FY 17-18 appropriations for these beds while negotiations for the FY 17-18 contract are underway.

#### **Background:**

Institutions for Mental Disease (IMD): The Department of Behavioral Wellness provides a continuum of services, including inpatient treatment services to best meet the needs of individuals with severe mental illness. IMDs are facilities including hospitals, nursing facilities, or other institutions of more than 16 beds that are primarily engaged in providing diagnosis, treatment, or care of persons with mental illness, including medical attention, nursing care, and related services. Due to the Federal IMD Exclusion, these services are not reimbursable by Medi-Cal for clients between the ages of 21 and 65. There are a limited number of these highly structured residential treatment services in California and none in Santa Barbara County. Behavioral Wellness examines the current caseload and historical use of IMD facilities in order to project the following year's contract amounts within Department's budget constraints. Behavioral Wellness contracts with IMDs, such as Aurora Vista Del Mar, that are licensed as Acute Psychiatric Hospitals. Acute Psychiatric Hospitals are used only for clients with emergency mental health needs meeting the criteria of Welfare and Institutions Code (WIC) Section 5150, and bed rates are significantly higher due to the hospital license, compared with other types of IMDs, which are locked facilities used to treat ongoing psychiatric needs. Due to limited bed availability at each IMD, Behavioral Wellness contracts with a number of IMDs throughout the State.

Aurora Vista del Mar (AVDM): Acute Psychiatric Hospitals are used only for clients with emergency mental health needs who are determined to be a danger to themselves or others or gravely disabled pursuant to Welfare and Institutions Code §5150, or who meet medical necessity criteria, as defined in the California Code of Regulations Title 9 §1820.205. When the County's 16-bed Psychiatric Health Facility (PHF) is full, Santa Barbara County clients are placed at other out-of-county Acute Psychiatric Hospitals, primarily AVDM. The contract with AVDM provides funding for up to nine (9) County clients per day.

Due to the fact that Behavioral Wellness and AVDM are still negotiating FY 17-18 rates, we are extending the term of the FY 16-17 to cover services during July 2017. AVDM has agreed to continue providing services to Behavioral Wellness clients through the month of July at the FY 16-17 rates.
