

**FIFTH AMENDMENT TO AGREEMENT**  
between  
**COUNTY OF SANTA BARBARA**  
and  
**CITY OF LOMPOC**  
for  
**ANIMAL CONTROL SERVICES**

**Effective July 1, 2017**

**THIS IS THE FIFTH AMENDMENT TO THE AGREEMENT** (hereafter Fifth Amendment) for Animal Control Services (hereafter Agreement), made by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter COUNTY), and the City of Lompoc, a municipal corporation in Santa Barbara County (hereafter CITY).

**WHEREAS**, the parties desire to amend the Agreement to extend the term of the Agreement; and

**WHEREAS**, this Fifth Amendment incorporates the terms and conditions set forth in the Agreement, First Amendment, Second Amendment, Third Amendment and Fourth Amendment, except as modified by this Fifth Amendment.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CITY hereby agree to amend the Agreement as follows:

1. **Definitions.** Capitalized terms used in this Fifth Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

2. **Amendments.**

The Agreement is amended as follows:

5. **TERM.** The term of this Agreement shall be from July 1, 2017 through July 31, 2017.

6. **COMPENSATION OF COUNTY.** For services rendered from the COUNTY operated shelter in Lompoc, between July 1, 2017 and July 31, 2017, CITY shall pay COUNTY \$25,127 billed in one monthly payment of \$25,127. The monthly payment COUNTY shall be made within thirty (30) days after receipt of an invoice. The invoices shall be delivered to the CITY address specified in Section 3, NOTICES of Agreement.

3. **Counterparts.** This Fifth Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
