# **Summary Text:**

This item is on the agenda to complete requirements by the State for reporting on Road Maintenance Annual Plan (RdMAP) projects funded by the Road Maintenance and Rehabilitation Account (RMRA) as provided by Senate Bill 1.

On July 25, 2017, your Board approved the 2017/18 RdMAP and associated maintenance projects. Funding for these projects were included in the budget adopted June 14, 2017. Since then, reporting and other requirements have been finalized and include the following:

• All projects proposed to receive funding must be included in a City or County budget that is adopted by the applicable City Council or County Board of Supervisors at a regular public meeting [SHC 2034(a)(1)]. This was completed June 14, 2017.

  - o a description and the location of each proposed project
  - o a proposed schedule for the project's completion
