Title: CSD - Increase appropriations for library consultant services

Budget Action: Increase appropriations of \$57,000 in Community Services Department, General Fund, Services and Supplies funded by release of committed fund balance (\$57,000).

Justification: On May 2, 2017, Board gave staff direction to seek a library consultant to evaluate the current Countywide library service delivery system, funding model, and recommended improvements for the County to consider. The proposed consultant fees are anticipated to be approximately \$75,000. In FY2016-17, CSD was able to designate \$57,000 in salary savings to be used for the study, with the remaining contract balance, up to an additional \$18,000, coming out of one time library funding already budgeted.
