(c) This section shifts the burden of CEQA compliance from the local agency ... to the California Coastal Commission. The Coastal Commission's program of certifying local coastal programs...has been certified under Section 21080.5, Public Resources Code.

Reasons to support exemption findings: In certifying those portions of the Eastern Goleta Valley Community Plan, Coastal Zoning Ordinance, and Eastern Goleta Valley Residential Design Guidelines that apply within the Coastal Zone, the California Coastal Commission complied with CEQA, completing environmental review. CEQA Guidelines Section 15265 states that CEQA does not apply to local governments to adopt a local coastal program, and shifts the burden of CEQA compliance to the Coastal Commission. Thus, the Board of Supervisors' action to acknowledge and accept the Coastal Commission's certification of a Local Coastal Program amendment with 13 suggested modifications is exempt from further environmental review.

Nevertheless, in approving the Eastern Goleta Valley Community Plan as a whole, which applies to both inland and coastal areas of the Eastern Goleta Valley, and the amendments to the Coastal Zoning Ordinance on October 20, 2015, the County relied upon the Eastern Goleta Valley Community Plan Final Environmental Impact Report (EIR) for environmental review, which the Board of Supervisors certified on October 20, 2015. The EIR (14EIR-00000-00005) analyzed impacts associated with the whole of the project, inland and coastal, associated with Case Nos. 14GPA-00000-00018, 14GPA-00000-00019, 11ORD-00000-00015, 13ORD-00000-00011, 11RZN-00000-00002, and 15RZN-00000-00004. In adopting the Eastern Goleta Valley Residential Design Guidelines on November 21, 2006, which also applies to both the inland and coastal areas of the Eastern Goleta Valley, the Board of Supervisors found the project to be exempt pursuant to CEQA Guidelines Sections 15305 and 15183.
