That the Board of Supervisor:

- a) Approve and authorize the Chair to execute the attached Statement of Final Quantities for the Construction of Woodmere Drive Barrier Wall Project; County Project No. 862381, Fourth Supervisorial District for work performed and materials supplied by Souza Construction, Inc., (a Tri-County vendor), P.O. Box 3810, San Luis Obispo, CA 93401, in the amount of \$317,704.
- b) Determine that the Woodmere Drive Barrier Wall project was found by your Board to be exempt from the provisions of California Environmental Quality Act pursuant to State Guidelines Section 15301(c) on March 21, 2017, a Notice of Exemption was filed on that basis, and the proposed action is within the scope of the attached Notice of Exemption.

Summary Text:

This item is on the agenda to approve the project as constructed and the attached Statement of Final Quantities. The project consisted of constructing the Woodmere Drive Barrier Wall. There were three segmented barrier walls that filled gaps in an existing berm system parallel to the U.S. 101. The height of the wall is up to 10 feet tall, and the total length of the barriers wall is approximately 550 feet.

On March 21, 2017, your Board awarded the above referenced construction contract to Souza Construction, Inc. and construction work began on April 17, 2017. The Director of Public Works accepted this project as complete on September 6, 2017. This project was completed on time and on budget. No change orders were issued for this contract.

Background:

Woodmere Barrier Wall is located on Woodmere Drive, parallel to the U.S. 101. On November 20, 2014, the SBCAG Board approved this project.

This construction project is fully funded by Regional Measure A, through SBCAG for a total amount of \$317,704. This funding is provided to the County for the construction of barrier walls. Funds for construction were budgeted for FY 2016/17 and 2017/18 in Dept. 054, Fund 0017, Org Unit 0600, Program 2830, and Account Line 7510. No County funding was utilized.
