Recommended Actions: That the Board of Supervisors:

- A) Approve, ratify, and authorize the chair to execute a First Amendment to the Agreement for Services of Independent Contractor with **Aurora Vista Del Mar Hospital** (not a local vendor), for the provision of Acute Inpatient Services, to add new processes and rates effective November 1, 2017 and to extend the contract through June 30, 2018, increasing the contract amount by \$710,180 for a new total contract amount not to exceed \$2,229,880 for the period August 1, 2017 through June 30, 2018.
- B) Determine that the above actions are government fiscal activities or funding mechanisms which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment, and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA guidelines.

Summary Text:

This contract amendment allows Behavioral Wellness to revise Aurora Vista Del Mar Hospital's (AVDM) contract to incorporate new Utilization Review Processes, Performance Measures and Outcomes and add an Observation Day Rate. It also extends the term of the contract and increases the

total contract amount by \$710,180. The Department of Behavioral Wellness provides a continuum of mental health and substance use disorders to Santa Barbara County residents, in part through contracted providers including Community-Based Organizations (CBOs). Contracts with facilities providing services at various levels of care are key to ensuring that the needs of clients are optimally met. Due to contract negotiations that extended beyond the June 30, 2016 date of Aurora Vista Del Mar's (AVDM) FY 16-17 contract, in July 2017, the Board of Supervisors approved a one month extension of the contract to cover services for the month of July. At the end of the extension, Behavioral Wellness and AVDM still had not finalized negotiations. Because of this, the Board of Supervisors approved a short-term contract with AVDM from August 1, 2017 through October 31, 2017. In mid-October, Behavioral Wellness and AVDM were able to come to an agreement on all terms. Approval of the current recommended actions will allow Behavioral Wellness to extend the contract with AVDM until the end of the fiscal year.

Background:

Institutions for Mental Disease (IMD): The Department of Behavioral Wellness provides a continuum of services, including inpatient treatment services to best meet the needs of individuals with severe mental illness. IMDs are facilities including hospitals, nursing facilities, or other institutions of more than 16 beds that are primarily engaged in providing diagnosis, treatment, or care of persons with mental illness, including medical attention, nursing care, and related services. Due to the Federal IMD Exclusion, these services are not reimbursable by Medi-Cal for clients between the ages of 21 and 65. There are a limited number of these highly structured residential treatment services in California and none in Santa Barbara County. Behavioral Wellness examines the current caseload and historical use of IMD facilities in order to project the following year's contract amounts within the Department's budget constraints. Behavioral Wellness contracts with IMDs, such as Aurora Vista Del Mar, that are licensed as Acute Psychiatric Hospitals. Acute Psychiatric Hospitals are used only for clients with emergency mental health needs meeting the criteria of Welfare and Institutions Code (WIC) Section 5150, and bed rates are significantly higher due to the hospital license, compared with other types of IMDs, which are locked facilities used to treat ongoing psychiatric needs. Due to limited bed availability at each IMD, Behavioral Wellness contracts with a number of IMDs throughout the State.

Aurora Vista del Mar (AVDM): Acute Psychiatric Hospitals are used only for clients with emergency mental health needs who are determined to be a danger to themselves or others or gravely disabled pursuant to Welfare and Institutions Code §5150, or who meet medical necessity criteria, as defined in the California Code of Regulations Title 9 §1820.205. When the County's 16-bed Psychiatric Health Facility (PHF) is full, Santa Barbara County clients are placed at other out-of-county Acute Psychiatric Hospitals, primarily AVDM. During the first Quarter of FY 17-18, there was a daily average of 8.6 clients per day. Currently, Behavioral Wellness has 5 clients placed at AVDM's facility.

Performance Measure:

For FY 17-18, Behavioral Wellness added the following Outcomes and Measures to AVDM's contract:

• Documentation standards will meet the State Department Health Care Services "medical necessity" so that upon utilization review by Behavioral Wellness QCM, disallowance by Contractor does not exceed a percentage to be determined; Behavioral Wellness has not yet collected enough data to determine the target percentage.

• For all clients shared by Contractor and County Behavioral Wellness, contact between Contractor's physician to County's physician contact will occur at least once during each client's in-patient stay at least 90% of the time.
