Project Purpose

 Provide a 20 year regional solid waste management plan.

 Meet and exceed recently approved state solid waste management requirements.





Project Timeline

- Final SEIR certified and Tajiguas Resource Recovery Project (TRRP) approved by BOS in July 2016.
- Material Delivery Agreements with partner jurisdictions and MarBorg Industries approved in December 2016.
- Financing activities undertaken between August 2016 February 2017.
- Permitting issue identified in February 2017.


Revised Project Summary

- Project revised to relocate the AD Facility outside the Coastal Zone.
- Replacement and relocation of LFG control system engine and flare.
- Amended Waste Disposal Facility Overlay.






AD Facility Area



Comprehensive Plan Amendment

- Existing Waste Disposal Facility Overlay = 352.75 acres.
- Revised Waste Disposal Facility Overlay = 301.68 acres.
 - 4.48 acres added to Waste Disposal Facility Overlay to accommodate ADF.
 - 55.55 acres removed from Waste Disposal Facility Overlay.
 - No adjustment along the Coastal Zone boundary.

All TRRP facilities would be located within the Waste Disposal Facility Overlay.





Comprehensive Plan and Gaviota Coast Plan Consistency

Key Policy Areas:

- Visual Resources
- Biological Resources
- Energy and Climate Action Plan
- Air Quality
- Public Facilities



Gaviota Coast Plan identifies the TRRP, including AD Facility and MRF.

Planning Commission Recommendation

On August 30, 2017, the County Planning Commission:

- Recommended that the BOS adopt a resolution to amend the Comprehensive Plan.
- Recommended that the BOS make findings for approval.
- Made Government Code §65402 determination of conformity.

Summary of Environmental Analysis

CEQA Addendum prepared (August 2017, Revised October 2017).

- All impacts (117) reanalyzed for the Revised TRRP.
- Technical Reports and visual simulations updated.
- Additional biological and cultural resource field surveys completed.

Addendum to 12EIR-00000-00002

- No substantial changes that would require major revisions to EIR.
- 2. No substantial changes have occurred with respect to circumstances under which the project is undertaken which would require major revisions to EIR.
- 3. No new information of substantial importance which was not known at the time the previous EIR was certified has become available.

MSB Contract Amendment

- On July 12, 2016, BOS approved contract between the County and MSB Investors, LLC for the Development and Operation of the TRRP.
- The BOS approved subsequent contract amendments in 2016 and February 2017.

MSB Contract Amendment

- In March 2017, County staff requested MSB to submit a modified project design with associated costs.
 - Addition of LFG engine procurement and operation.
 - Sale by County to MSB for LFG collected at the Tajiguas Landfill site.
 - Increased pre-construction, construction, and operational costs.
 - Inclusion of updated exhibits.

Updated Project Costs

- Capital costs increased \$19,693,000.
 - \$9,271,000 to replace the LFG engines.
 - \$10,422,000 to relocate AD.
- Operational costs increased from \$15.15 to \$16.23/ton.
- Need to update full financial model once financing. documents are revised, anticipate:
 - Less than 5% increase to facility tip fee.
 - Approximately 2% increase to ratepayer on trash bill.

Financing

- Due to the delay in the project, the County declined the New Clean Renewable Energy Bond (CREB) Volume Cap for the TRRP.
- Financing for the Revised TRRP includes:
 - Updating financial documents.
 - Presenting financial plan to the Debt Advisory Committee.
 - Returning to the BOS for approval of financial documents.
 - Submitting CREB Volume Cap application to the IRS, if funds available.

Staff Recommendations Summarized

- a) Make findings to approve the Comprehensive Plan Amendment.
- b) Consider the environmental documents and find that no further EIR or ND shall be prepared for this project.
- c) Receive the Planning Commission's conformity report.
- d) Adopt a resolution amending the Waste Disposal Facility Overlay boundary.

Staff Recommendations Summarized

- e) Approve and authorize the chair to execute the Second Amendment to the Amended Contract with MSB.
- f) Authorize the Treasurer-Tax Collector to submit an application to the IRS for an application of New Clean Renewable Energy Bond Volume Cap.
- g) Direct agencies to work with the CEO, Auditor Controller, and County Counsel to update documents to finance the project's construction.

CRLF in South Sedimentation Basin

- Recent surveys found in CRLF in the south sedimentation basin.
- SEIR noted CRLF may be present in this area and operational impacts here were potentially significant.
 - SEIR pp. 4.3-42 to 4.3-44; Appendix E, Sec. 5.4.2.
- MM TRRP BIO-6 remains relevant to mitigate these impacts to less than significant.
