# Dental: Four (4) Grievances (9.5%)

I reviewed four (4) grievances related to dental treatment for July. Each grievance addressed a general request for dental service due to tooth pain and infection. Each person received antibiotics and pain medications, and was scheduled for follow-up treatment by the dentist or was treated by the dentist. No follow-up was needed to determine a resolution.

## Mental Health: Four (4) Grievances (9.5%)

During this period, there were four (4) mental health grievances for review. All four (4) were requests for Mental Health medications or adjustment of existing medication. Each received treatment with the Psychiatrist that resulted in either the order of new medication or the adjustment of current medication. No follow-up was needed.

## Medications: Four (4) Grievance (9.5%)

I reviewed four (4) grievances related to medications other than Mental Health medications. The majority of these requests resulted in treatment and medication being ordered. One required follow-up to determine an appropriate outcome.

#### Medical: Thirty (30) Grievances (71.5%)

I reviewed thirty (30) general medical grievances for this period. Sick call, MD and follow-up appointments or other similar actions addressed the majority of these complaints. Two (2) of these grievances were duplicates of a previously submitted grievance. One (1) grievance was resolved on appeal, and one (1) individual refused to attend the appointment indicating "issue resolved". Two (2) grievances required follow-up to determine a resolution, but were ultimately resolved.

#### **Observations & Recommendations:**

The average time between the grievance filing and a response for medical or mental health grievances during this period is 5.1 days. One grievance exceeded the fifteen (15) day response requirement by 37 days, as the grievance was misplaced by Operations. The grievance was received by medical on 8/10/17 and was responded to on that same date.

During this period, the total number of medical related grievances decreased from previous months, indicating a decrease of 36.4% comparing the 42 grievances for this month to the average of 66 grievances per month filed in the previous quarter.

In the month of July, there were  $1,266^{1}$  requests for medical related services, of which fourty-two (42) or 3.2% resulted in a grievance.

During this same period, there were one hundred fifty-one (151) total grievances filed, of which forty-two (42) or 27.8% were medical related.

During July the sheriff's office received twelve (12) community inquiries. These inquiries included two (2) dental inquiries, four (4) mental health inquiries, two (2) medication inquiry and four (4) general medical inquiries. I have received responses providing a resolution to the stated concerns for ten (10) inquiries. One person was out of custody when the query was received and one individual refused mental health services. Only two (2) of the parties of concern had filed a grievance prior to the community inquiry.

The Medical, Mental Health, and Corrections Committee meeting was held on July 27, 2017, but I was unable to attend.

# Dental: Three (3) Grievances (11.54%)

There were three (3) grievances related to dental treatment for August. All three (3) dealt with requests for dental treatment related to tooth pain and the need for antibiotics. Each was addressed by prescriptions for pain meds, antibiotics, and treatment by the dentist. One (1) grievance was a duplicate to a previously filed grievance. One (1) person refused follow-up care with the dentist. No follow-up was needed to determine an appropriate outcome.

## Mental Health: Three (3) Grievances (11.54%)

During this period, there were three (3) mental health grievances for review. One (1) grievance indicated that Psychiatric medications are being given illegally, however the subject has not been prescribed psychotropic medications at any time while in the facility. Medication records confirm only acid reducers administered. Two (2) grievances were requests for Mental Health medications or adjustment of existing medication. Each received treatment with the Psychiatrist or Tele-psych that resulted in either the order of new medication or the adjustment of current medication. No follow-up was needed to determine an appropriate outcome.

## Medications: Ten (10) Grievance (38.46%)

I reviewed ten (10) grievances related to medications other than Mental Health medications. All but one of these requests resulted in treatment and either the medication being ordered or continued with the final one (1) grievance being resolved on appeal. Two (2) grievances were duplicates to previously filed grievances. No grievances required follow-up to determine an appropriate outcome.

## Medical: Ten (10) Grievances (38.46%)

I reviewed ten (10) general medical grievances for this period. Sick call, MD and follow-up appointments or other similar actions addressed each of these complaints. No grievances required follow-up to determine a resolution.

## **Observations & Recommendations:**

The average time between the grievance filing and a response for medical or mental health grievances during this period is 5.3 days. No grievances exceeded the fifteen (15) day response requirement.

During this period, the total number of medical related grievances decreased from previous months, indicating a decrease of 60% comparing the 26 grievances for this month to the average of 66 grievances per month filed in the previous quarter.

# Santa Barbara Sheriff's Office Grievance Review August 2017

In the month of August, there were  $2,373^1$  requests for medical related services, of which twentysix (26) or 1.1% resulted in a grievance. This is a significant reduction comparative to the average of 4.6% filed during the previous quarter.

During this same period, there were one hundred twenty-four (124) total grievances filed, of which twenty-six (26) or 21% were medical related.

During August the sheriff's office received no community inquiries.

The Medical, Mental Health, and Corrections Committee meeting was held on August 19, 2017. Of note is that the Public Health audit has begun and will likely be completed in September. Behavior Wellness and Public Health now have representation on the committee and will participate moving forward. The information presented by CFMG is significantly more thorough then that presented by the previous provider. These include increased statistical information and detail including types and numbers of requests, emergency transportations, medication dissemination detail, etc. This presents a very good overview of the treatment processes occurring within the facility on a monthly basis.

## Dental: Zero (0) Grievances (0.00%)

There were no (0) grievances related to dental treatment for September.

# Mental Health: Four (4) Grievances (10.26%)

During this period, there were four (4) mental health grievances for review. One (1) grievance indicated the need to be assesses by Mental Health. Three (3) grievances were requests for Mental Health medications or adjustment of existing medication. Each received treatment with the Psychiatrist or Tele-psych that resulted in either the order of new medication or the adjustment of current medication. One (1) person refused the medication because the order indicated crush and float as the delivery method. No follow-up was needed to determine an appropriate outcome.

## Medications: Six (6) Grievance (15.38%)

I reviewed six (6) grievances related to medications other than Mental Health medications. The majority of these requests resulted in treatment and medication being ordered. One person claims a reaction to the medication, but the person has been off all medications since August 8, 2017. Two (2) of these grievances were resolved on appeal. No grievances required follow-up to determine an appropriate outcome.

## Medical: Twenty-nine (29) Grievances (74.36%)

I reviewed twenty-nine (29) general medical grievances for this period. Sick call, MD and follow-up appointments or other similar actions addressed the majority of these complaints. One (1) of these grievances was resolved on appeal and five (5) of these were duplicates to previously filed grievances. No grievances required follow-up to determine a resolution.

## **Observations & Recommendations:**

The average time between the grievance filing and a response for medical or mental health grievances during this period is 3.7 days. No grievances exceeded the fifteen (15) day response requirement.

During this period, the total number of medical related grievances decreased from previous months, indicating a decrease of 40.9% comparing the 39 grievances for this month to the average of 66 grievances per month filed in the previous quarter.

In the month of September, there were  $1,626^{1}$  requests for medical related services, of which thirtynine (39) or 2.4% resulted in a grievance. This is a 48% reduction comparative to the average of 4.6% filed during the previous quarter.

During this same period, there were one hundred thirteen (113) total grievances filed, of which thirty-nine (39) or 34.5% were medical related.

During September the sheriff's office received three (3) community inquiries, of which all three have received an appropriate response.

The Medical, Mental Health, and Corrections Committee meeting was held on August 19, 2017. Of note is that the Public Health audit was presented during this meeting. CFMG is largely compliant with the requirements of the contract, with the areas of deficiency being related to how information is recorded. As an example, there is no indicator in the records if a person was released from custody prior to obtaining a particular service, thus they are counted as not being compliant, when in fact a release would indicate compliant due to release. The Committee discussed several methods to correct these record-keeping issues and we are confident that these will improve the audit process and likely the outcome measures. The information presented by CFMG continues to be more thorough then that presented by the previous provider. These include increased statistical information and detail including types and numbers of requests, emergency transportations, medication dissemination detail, etc. This presents a very good overview of the treatment processes occurring within the facility on a monthly basis.
