Summary Text:

This item is on the agenda in order to approve amendments to the Agreements of Services of Independent Contractor with Stantec, Wallace Group, and MNS Engineers Inc. for surveying services. On September 2016, the Board entered into agreements with these three consultant firms to provide surveying for project design, right-of-way, and construction on an as needed project basis. These amendments will extend the terms of the agreements to December 31, 2019 and increase the not-to-exceed amounts to \$200,000.

To initiate work, Notices to Proceed will be issued by project and will specify tasks, deliverables, timelines, and budget. Each Notice to Proceed will be approved by the Public Works Director or designee.

Background:

The original agreements for as-needed surveying services proved invaluable to the Flood Control District on a variety of projects in the one-year they were in place. The requested contract amendments for surveying work will provide for continuation of their ongoing services until the end of 2019.
