AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

between

COUNTY OF SANTA BARBARA

And

ANACOMP, INC.

(BC-17-272) FIRST AMENDMENT

Effective January 9, 2018

THIS FIRST AMENDMENT (hereinafter referred to as First Amendment) is made by and between the County of Santa Barbara, a political subdivision of the State of California having its principle place of business at 105 East Anapamu Street, Room 304, Santa Barbara, California, 93101 (hereafter COUNTY) and Anacomp Inc. with an address of 1935 Avenida Del Oro, Suite E, Oceanside, CA 92056 (hereafter CONTRACTOR), is effective as of January 9, 2018 (“First Amendment Effective Date”).

WHEREAS, the parties desire to amend the term of the Agreement; and

WHEREAS, this First Amendment incorporates the terms and conditions set forth in the Agreement, approved by the County of Santa Barbara.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. **Definitions.**

Capitalized items used in this First Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

2. **Amendments.**

This Agreement is amended as follows:

Section 4 TERM. CONTRACTOR shall commence performance on or about April 11, 2017 and end performance no later than July 21, 2020 unless otherwise directed by COUNTY or unless earlier terminated.

3. **Counterparts.** The First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.

4. **Ratifications.** The terms and provisions set forth in this First Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, as expressly modified and superseded by this First Amendment, are ratified and confirmed and shall constitute in full force and effect, and shall continue to be legal, valid, binding and enforceable obligations of the parties.
