Summary Text:

This item is on the agenda in order to approve the prequalified consultant listings (Attachment A) for professional services for the Public Works Department (Department). The prequalified list of consultants will be used when contracting for the identified service categories of work for the next three years.

The RFQ Notice was mailed to more than 300 consultants from an existing 2013 mailing list and was also posted on our website. The RFQ was available on the Department's RFQ Online Information System and notices were also emailed to the over 300 registered consultants. Public Notices were published in the Santa Barbara Newspress and Santa Maria Times on October 13 and 20, 2017.

This RFP processes streamlines the prequalification of professional services; while assuring a fair and competitive contracting process. Having prequalified firms readily available to hire saves time and staffing costs and has proven to be an invaluable tool for the Department. The Department intends to go out to RFQ for these services every three years.

The selection criteria and rating process was outlined in the RFQ and provided to the consultants. The firms that submitted Statement of Qualifications (SOQs) that met the criteria and accumulated the required score are considered prequalified and are included in the listing by category.

Notices were emailed to all of the firms that submitted a SOQ notifying them if they met the criteria to be pregualified. The consultants had a 5-day appeal process; no appeals were received.

Background: This professional services selection process complies with the Federal Government's Brooks Act and the State's Mini-Brooks Act, which govern professional services selection.

The Public Works Department has been performing similar RFQ processes to prequalify firms for professional services since 1997.
