Justification: This budget revision will release \$24,400 from the Public Defender Programs committed fund balance account to capital assets to fund the purchase of two

64-terabyte servers, one for operations and one for backup and security. Data storage is in critical condition and servers need to be purchased to meet the paperless needs of the department in conjunction with its case management system. The storage needed to accomplish this mission is estimated at six terabytes per year; therefore, it is expected that this server purchase will provide sufficient data storage for ten years of operations. These servers will be

hosted by County ICT and ongoing port charges associated with the servers are already included in the department's budget.
