Section 15378(b)(2) specifies that a project does not include general policy making or administrative activities of governments that will not result in direct or indirect physical changes in the environment. The staff briefing and request for the Board's comments and direction is an administrative activity that does not authorize new development and will not result in direct or indirect physical changes in the environment.
