DHCS has invoiced the department, although the department has a scheduled Informal Appeal of all audit findings scheduled for May 22, 2018. The State Welfare and Institutions code requires the payment of preliminary audit findings prior to appeal. If appeal of audit findings is granted, the State is required to

repay all previously repaid amounts with interest.
