Reasons to support exemption findings: The 2017 Comprehensive Plan Annual Progress Report contains three key components. First, the report summarizes the projects that the Planning and Development Department undertook in 2017 to maintain and implement the Comprehensive Plan. Second, the report provides housing production statistics, including separate statistics for Isla Vista and

Mission Canyon. Lastly, the report includes the "Housing Successor Annual Report, Low and Moderate Income Housing Asset Fund, Fiscal Year 2016-2017."

CEQA Guidelines Section 15060(c)(3) states that an activity is not subject to CEQA if the activity is not a "project." Section 15378(b)(5) specifies that projects do not include "[o]rganizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment." As described above, the 2017 Comprehensive Plan Annual Progress Report is an administrative activity that does not authorize new development or otherwise result in direct or indirect physical changes in the environment. Therefore, the report is not a project as defined by CEQA Guidelines Section 15378(b)(5) and is not subject to CEQA per CEQA Guidelines Section 15060(c)(3).
