## RE: 2017 Comprehensive Annual Progress Report

Hearing on the request of the Planning and Development Department that the County Planning Commission (1) receive and file the 2017 Comprehensive Plan Annual Progress Report; (2) determine that the County Planning Commission's actions regarding the 2017 Comprehensive Plan Annual Progress Report are not subject to CEQA pursuant to CEQA Guidelines Sections 15060(c)(3) and 15378(b)(5); and (3) authorize staff to provide the 2017 Comprehensive Plan Annual Progress Report to the Board of Supervisors, Governor's Office of Planning and Research, California Department of Housing and Community Development, pursuant to Government Code 65400, and to the city of Santa Barbara pursuant to the Board of Supervisors' action to adopt the Mission Canyon Community Plan (April 1, 2014).

## Dear Honorable Members of the Board of Supervisors:

At the County Planning Commission hearing of February 28, 2018, Commissioner Parke moved, seconded by Commissioner Ferini and carried by a vote of 5 to 0 to:

- 1. Receive and file the 2017 Comprehensive Plan Annual Progress Report, as revised and dated February 22, 2018, to include the Montecito Planning Commission's and County Planning Commission's action letters on the Long Range Planning Division Fiscal Year 2018-2019 Work Program, dated February 21, 2018, and February 28, 2018, respectively (Attachment A of the County Planning Commission Memorandum dated February 23, 2018);
- 2. Determine that the County Planning Commission's actions regarding the 2017 Comprehensive Plan Annual Progress Report are not subject to CEQA pursuant to CEQA Guidelines Sections 15060(c)(3) and 15378(b)(5) (Attachment B of the staff report dated February 20, 2018); and
- 3. Authorize staff to provide the 2017 Comprehensive Plan Annual Progress Report to the Board of Supervisors, Governor's Office of Planning and Research, California Department of Housing and Community Development, and city of Santa Barbara.
