AN ORDINANCE TO SET SEWER CONNECTION CHARGES AND SEWER SERVICE CHARGES FOR COUNTY SERVICE AREA 12 IN THE MISSION CANYON AREA

The Board of Supervisors of the County of Santa Barbara ordains as follows:

ARTICLE I

Section 1.

The following service charges are hereby set for sewer service within County Service Area 12.

Section 2.

The charges for sewer service, including the costs of operation and maintenance, in County Service Area 12 shall be THREE HUNDRED SIX DOLLARS AND SIXTY TWO CENTS (\$306.62) annually for each residential dwelling unit and each dwelling equivalent.

ARTICLE II

Section 1.

The following connection charge is hereby set for connection to any of the facilities or lines of County Service Area 12.

Section 2.

The charges for connection of a building sewer to the public community sewer in County Service Area 12 shall be FIVE THOUSAND SIX HUNDRED THIRTY-THREE DOLLARS (\$5,633.00) for each dwelling unit or dwelling unit equivalent. Such connection charge shall not be applied to any building or parcel which has been fully assessed as part of the Mission Canyon assessment district or any other assessment district proceedings for construction of sanitary sewer facilities.

ARTICLE III

Section 1.

The Board of Supervisors may determine by resolution the manner and place of collection and payment of said sewer service charges and connection fees.

ARTICLE IV

Section 1.

The sewer service charges specified in Article I hereof shall be collected at the same time and in the same manner, and subject to the same penalties and priority of lien, as county taxes are collected, and all laws providing for the collection and enforcement of county taxes shall apply to the collection and enforcement of the charges, as provided in Section 25215 et seq. of the Government Code.

Section 2.

For the purpose of collecting the sewer service charges on the tax roll, the sewer service charges specified in Article I hereof shall become operative and effective for fiscal year 2018-2019

and shall continue in effect and be operative for each fiscal year thereafter, or as modified by subsequent ordinances.
