SUBJECT: Acceptance of Cash Donation from the City of Goleta Public Safety Donations

Recommended Actions:

That the Board of Supervisors:

- a) Authorize the Fire Department to accept a cash donation up to \$174,000 from the City of Goleta PSD Fund to purchase the OPTICOMTM Priority Control System ("Opticom System"); and
- b) Approve Budget Revision Request #BJE-0005593 to account for the increase to the appropriation of Donation Revenue, Capital Assets and Services and Supplies; and
- c) Determine that these activities are exempt from California Environmental Quality Act (CEQA) review per CEQA Guideline Section 15061 (b) (3), since it can be seen with certainty that there is no possibility that the activities may have a significant effect on the environment.

Summary Text:

The recommended action by the Board of Supervisors to authorize the acceptance of the referenced cash donation is in accordance with California Government Code Section 25355, and Policies & Procedures for the Acceptance of Donations and Gifts to the County.

This donation from the City of Goleta allows the Santa Barbara County Fire Department (SBCFD) to equip our vehicles and apparatus, and high-traffic intersections within the City of Goleta, with "Opticom System" infrared traffic preemption devices.

Background:

Traffic signals controlled with the "Opticom System" will change to green and provide right of way in the path of responding SBCFD apparatus, using the latest in Global Positioning System (GPS) technology. This system will result in improved safety during emergency responses as well as reduced response times within the City of Goleta.

The donated funds will be used to offset the costs to purchase and install the system in at least 14 intersections within the City of Goleta, and approximately 19 of 24 identified SBCFD fire engines, ladder trucks, and ambulances, as follows:

Narrative: The cash donation of \$174,000 will be accounted for as a one-time appropriation of Miscellaneous Revenue – Other Donations, Capital Equipment and Instruments and Equipment < \$5k. The "Opticom System" equipment will be purchased using Government Services Administration (GSA) contract pricing; repair or replacement of the equipment for the first five years is covered under the "Opticom System" warranty.

The SBCFD will use Fire District funds to cover an estimated \$18,000 in additional costs to equip the remaining identified units included in this project.
