NOW, THEREFORE, BE IT RESOLVED, that the <u>County Public Works</u> <u>Director</u> is authorized to execute and file an appropriate claim and necessary claim amendments pursuant to applicable rules and regulations promulgated hereunder, together with all necessary supporting documents, with the Santa Barbara County Association of Governments for an allocation of TDA funds in FY 2018/2019;

BE IT FURTHER RESOLVED THAT the authorized claim include \$79,616 for SBCAG's regional transportation planning, \$200,000 for County transit and \$116,696 for pedestrian and bicycle facilities, \$2,206,483 for Santa Maria, Lompoc, Solvang, Guadalupe and Santa Maria Organization of Transportation Helpers, \$100,000 for County street and road purposes; and

BE IT FURTHER RESOLVED THAT a copy of this resolution be transmitted to the Santa Barbara County Association of Governments in conjunction with the filing of the claim.
