Budget Action: Increase appropriations of \$64,332 in Sheriff General Fund for Salaries and Benefits - Overtime (\$10,691), Services and Supplies (\$4,641) and Capital Assets (\$49,000) funded by unanticipated revenue from Intergovernmental - State
