FIFTH AMENDMENT

THIS IS THE FIFTH AMENDMENT (hereafter referred to as Fifth Amendment) to the Agreement for Designation as Level I Adult Trauma Center and Level II Pediatric Trauma Center for the period July 1, 2018, through June 30, 2019 (hereafter Agreement), by and between the County of Santa Barbara (COUNTY) and Santa Barbara Cottage Hospital (hereafter HOSPITAL).

WHEREAS, the Agreement is effective through June 30, 2018; and

WHEREAS, the parties desire to amend the Agreement to extend the term and adjust compensation; and

WHEREAS, HOSPITAL is designated as a Level I Adult Trauma Center and Level II Pediatric Trauma Center by Santa Barbara County EMS Agency and HOSPITAL has been found by COUNTY to have in place all the requirements as stated in the California Code of Regulations Title 22, Division 9, Chapter 7, Trauma Care Systems and is actively providing the level of care required for designation as a Level I Trauma Center; and

WHEREAS, COUNTY EMS Agency has the authority, as set forth in Health and Safety Code 1798.164, to recover costs associated with trauma center designation oversight; and

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. **Definitions.** Capitalized terms used in this Fifth Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

2. <u>Amendments.</u>

- a. The Agreement is amended as follows:
 - 4. <u>**TERM.**</u> The term of this Agreement shall be for the period of July 1, 2018 through June 30, 2019.
 - 2. **NOTICES**. Any notice or consent required or permitted to be given under this Agreement shall be given to the respective parties in writing, by first class mail, postage prepaid, delivered as follows:

- 3. **<u>Counterparts.</u>** This Fifth Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
- 4. <u>Effectiveness of Agreement.</u> Except as explicitly modified by this Fourth Amendment, all of the terms and provisions of the Agreement and all previous modifications and amendments, if any, are and remain in full force and effect.
