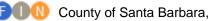
Justification: In response to the Thomas Fire and Montecito debris flow, Federal Emergency Management Agency (FEMA) funding was awarded to the County of Santa Barbara Behavioral Wellness department. Santa Barbara County Behavioral Wellness department has employed a contractor, The Mental Wellness Center (MWC), to implement the Crisis Counseling Program (CCP). MWC has the capacity to quickly hire paraprofessionals as well as licensed clinicians, as the organization is currently operating several paraprofessional and clinical program in the area. The county has contracted MWC to provide 2.0 FTE team leads and 12.0 FTEs crisis counselors, which will encompass a mixture of clinicians, para-professionals, fiscal, and data staff for a total of 16 FTEs.
