GIFT AGREEMENT

County agrees that this material shall be available for inspection according to the established procedures of the UCSB Special Collections Library and subject to the following conditions:

That the historical County records identified in the attached Inventory of Transferred Material (Exhibit A) remain in the public domain and are available for inspection, research and reproduction by members of the public during regular business hours of the UCSB Special Collections Library.

Pursuant to the Gift Agreement with the Regents of the University of California, the historical County records identified in the attached Inventory of Transferred Material (Exhibit A) are to be stored in perpetuity at the UCSB Special Collections Library and in a manner consistent with the professional preservation of historical County records. At no time shall any of these records be destroyed or otherwise disposed of.

If for any reason, should the UCSB Special Collections Library be unable to continue to store the historical County records identified in the attached Inventory of Transferred Material (Exhibit A), said records are to be returned to the County of Santa Barbara in a manner agreed upon by the UCSB Special Collection Library and the County of Santa Barbara.

County of Santa Barbara finds that the transfer of historic County records to the Special Collections Library of the University of California at Santa Barbara in the best interest of the County, and does not amount to a gift of public funds prohibited by the California Constitution, because it serves public purposes which include the preservation and access to public records.
