AMENDMENT NO. 1 TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR BETWEEN COUNTY OF SANTA BARBARA AND TETRA TECH BAS (BC-16-197)

This Amendment (hereinafter referred to as "Amendment No. 1") to the Agreement of Services of Independent Contractor (hereinafter referred to as "Agreement") is made by and between the County of Santa Barbara (hereinafter referred to as "COUNTY"), and Tetra Tech BAS (hereinafter referred to as "CONTRACTOR") with reference to the following:

WHEREAS, COUNTY and CONTRACTOR executed the Agreement, Contract BC-16-197 on May 3, 2016; and

WHEREAS, the previously agreed upon Statement of Work to be performed by CONTRACTOR is to be amended; and

WHEREAS, to accommodate the change in scope, the previously agreed upon Term is to be extended; and

WHEREAS, COUNTY and CONTRACTOR desire to amend the text of SECTION 4. TERM, EXHIBIT A, STATEMENT OF WORK and EXHIBIT B, PAYMENT ARRANGEMENTS to the Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, COUNTY AND CONTRACTOR agree to amend the Agreement as follows:

- 1. The text of **SECTION 4. TERM**, shall be deleted in its entirety and replaced by the following:
 - "CONTRACTOR shall commence performance on May 4, 2016 and end performance upon completion, but no later than December 31, 2019 unless otherwise directed by COUNTY or unless earlier terminated."
- 2. The text of EXHIBIT A, STATEMENT OF WORK, shall be deleted in its entirety and replaced by the following:

Contractor shall provide construction management services as set forth in the Tetra Tech BAS "Proposal For Construction Management Services for the Tajiguas Landfill Phase 2 and 3 Partial Final Closure Construction Project (Project Number 129913)" dated March 9, 2016. The detailed scope of work is stipulated in Attachment A-1 and is incorporated by reference. Tetra Tech BAS's Fee Estimate for proposed services is provided in Attachment A-2 and is incorporated by reference.

The first addendum to the scope of work is set forth in the Tetra Tech BAS "RE: PROPOSAL FOR EXTENDED CONSTRUCTION MANAGEMENT SERVICES FOR THE TAJIQUAS LANDFILL PHASE 2 & 3 PARTIAL FINAL CLOSURE CONSTRUCTION" dated March 28, 2018. The detailed scope of work and fee estimate for this addendum is stipulated in **Attachment A-3** and is incorporated by reference.

Caleb Moore, Richard Huffmire, and Julie Hauenstein shall be the primary individual(s) personally responsible for construction management services. CONTRACTOR may not substitute other persons without the prior written approval of CONTRACTOR's Designated Representative.

- 3. The text of **EXHIBIT B, PAYMENT ARRANGEMENTS**, Periodic Compensation (with attached Schedule of Fees), Sections A, B, C, D, and E shall be deleted and replaced by the following:
 - A. For CONTRACTOR services rendered under this Agreement for Phase 2 Closure Construction Management through June 30, 2018, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed \$525,089.

Amendment No. 1 to the Agreement for Services of Independent Contractor Between the County of Santa Barbara and Tetra Tech BAS

- B. For CONTRACTOR services to be rendered under this Agreement for Phase 3 Closure Construction Management, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed \$135,501.
- C. Extra Work required to complete the project may be authorized only if CONTRACTOR receives written approval by the COUNTY's designated representative as identified in Paragraph 1 of the Agreement at the same rate per unit as defined in **Attachment B1 (Schedule of Fees)**. The total amount of this contingency fund is \$12,000.00.
- D. Payment of services and/or reimbursement of costs shall be made upon CONTRACTOR's satisfactory performance, based on the scope and methodology contained in **EXHIBIT A** as determined by the COUNTY. Payment of services and/or reimbursement of costs shall be based upon the costs, expenses, overhead charges and hourly rates for personnel, as defined in **Attachment B1** (Schedule of Fees). Invoices submitted for payment that are based upon **Attachment B1** (Schedule of Fees) must contain sufficient enough detail to enable an audit of the charges and provide supporting documentation is so specified in **EXHIBIT A**.
- E. Monthly, CONTRACTOR shall submit to the COUNTY DESIGNATED REPRESENTATIVE an invoice or certified claim on the County Treasury for the service performed over the period specified. These invoices or certified claims must cite the assigned Board Contract Number. COUNTY DESIGNATED REPRESENTATIVE shall evaluate the quality of the service performed and if found to be satisfactory and with the cost basis of **Attachment B-1** shall initiate payment processing. COUNT shall pay invoices or claims for satisfactory work within 30 days of receipt of correct and complete invoices or claims from CONTRACTOR.
- F. COUNTY's failure to discover or object to any unsatisfactory work or billings prior to payment will not constitute a waiver of COUNTY's right to require CONTRACTOR to correct such work or billings or seek any other legal remedy."
- 4. Except as set forth in Sections 1 through 3 hereof, this Amendment No. 1 shall not modify of change any of the provisions of the Agreement and the parties to this Agreement are bound by its provisions, as amended herein.

Tetra Tech BAS (TtBAS) is pleased to present this proposal to provide extended construction management services for the Phase 3 portion of the Phase 2 & 3 Partial Final Closure Construction project at the Tajiguas Sanitary Landfill.

The Phase 2 & 3 construction documents specified a duration of 130 working days for the Phase 2 portion of the project and 85 working days for the Phase 3 portion of the project, or a total of 215 working days for completion of both phases.

As a result of issues associated with the availability of construction water at the site; and delays due to the above average and severe intensity of rainfall during the 2016-2017 winter season, several contract change orders were issued, or are pending, that extended the Phase 2 portion of the project well beyond the anticipated November 28, 2016 completion date. Those change orders are summarize as follows:

Through conservative time management and staffing adjustments during the course of the Phase 2 project, TtBAS was able to provide the additionally requested CM services within the allocated budget for the originally specified 215 working days for both the Phase 2 and Phase 3 projects.

The Phase 3 portion of the project is tentatively scheduled to begin construction in July 2018. Phase 3 is less complex than Phase 2 and should be somewhat less demanding with respect to CM oversight. Therefore, based on our recent discussions, TtBAS has prepared an adjusted Fee Schedule to provide options for the CM services required for the Phase 3 portion of the project. The attached Fee Schedule provides three options for your consideration.

- Option 1: Provide a full time staff engineer with oversight provided by a senior engineer/project manager (Julie Hauenstein) on an as needed basis.
- Option 2: Provided a full time construction manager.
- Option 3: Provide a senior engineer/project manager (Julie Hauenstein) on a part time basis (±2 days/wk) to provide oversight and coordinate with COA personnel.

To provide continuity between Phases 2 & 3, Rich Huffmire, Senior Construction Manager for Phase 2, will continue to provide oversight for review of submittals, progress payment applications, additional work items, and preparation of the Construction Management Report.

A detailed breakdown of this fee estimate is provided in the attached table. This cost estimate is for budgeting purposes only and work performed under this proposal will be billed on a time-and-materials, not-to-exceed basis in accordance with our contract rate schedule. TtBAS will not exceed the approved budgeted amounts without prior written approval by the County.

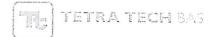
