### **Summary Text:**

On June 20, 2018, the Santa Barbara County Grand Jury published a report entitled "Pensions in Santa Barbara County". Today, the Board will consider the proposed response to the report, adopt their preferred response and authorize the Board Chair to sign the response letter. The Board is required to respond in writing to the Presiding Judge of the Superior Court by September 18, 2018.

# **Background:**

On June 20, 2018, the Santa Barbara County Grand Jury published a report entitled "Pensions in Santa Barbara County". The Grand Jury concluded in part that: "There are substantial liquidity and solvency risks to the sustainability of many of the public defined benefit pension plans in the County. Management of those risks may require new policy measures." The Jury also found "the highest risks in the plans of Lompoc (six pension plans), the City of Santa Barbara (four pension plans), and Santa Maria (seven pension plans), which are the largest in the County. It found moderate risks in Guadalupe (five pension plans) and Solvang (three pension plans). It found minimal to moderate risks in Buellton (two pension plans) and Goleta (two pension plans). Risks in SBCERS are moderate and well managed". (Underlining added.)

The Board of Supervisors is named as a responder to Findings 11 and 12 and Recommendations 1 and 2.

# **Additional Agencies Required to Respond:**

Cities of Carpinteria, Buellton, Goleta, Guadalupe, Lompoc, Santa Barbara, Santa Maria and Solvang.
