Second Amendment 2017-2018

TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

This Second Amendment (hereafter Second Amended Contract) to the Agreement for Services of Independent Contractor, <u>BC 18-002</u>, is made by and between the **County of Santa Barbara** (County) and **Locumtenens.com** (Contractor), for the continued services specified herein.

Whereas, Contractor represents that it is specially trained, skilled, experienced, and competent to perform the special services required by County and County desires to retain the services of Contractor pursuant to the terms, covenants, and conditions referenced herein;

Whereas, at the request of County, Contractor provides locum tenens temporary physicians who provide psychiatric services at County Mental Health facilities, and County has ongoing needs for psychiatric staff at outpatient facilities;

Whereas, Contractor provided, at the request of County, a greater number of services than contemplated by the original Agreement, and will incur expenses beyond the value of this Agreement. So as to compensate Contractor for the additional services to be rendered under the Agreement, this Second Amendment adds funds for Fiscal Year 17-18 in the amount of \$55,000, for a new Total Contract Maximum of \$1,855,000 through June 30, 2018.

Whereas, this Second Amended Contract incorporates the terms and conditions set forth in the Agreement approved by the County Board of Supervisors in May 2017 and the Fist Amended Contract approved by the Board of Supervisors in May 2018, except as modified by this Second Amended Contract.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, County and Contractor agree as follows:

- l. Delete <u>Section 1</u> of <u>Exhibit B</u>, and replace with the following:
 - 1. **CONTRACT MAXIMUM**. For services to be rendered under this contract, Contractor shall be paid at the rate(s) specified in the Schedule of Rates (Exhibit B-1), with a maximum value not to \$1,855,000.
- II. Delete Exhibit B-1, Schedule of Rates, and replace with the following:
