## **Recommended Actions:**

- a) Approve and authorize the Chair to execute the attached Agreement for Professional Legal Services between the County of Santa Barbara and the Meyers/Nave law firm in an amount not to exceed \$250,000 without written amendment; and
- b) Determine that the above action is not a project under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Sections 15378(b)(4) and 15378(b)(5) because it consists of government administrative or fiscal activities that will not result in direct or indirect physical changes in the environment.

#### **Summary Text:**

The County routinely requires legal advice and representation in defending against tort and real property claims and litigation. While the Office of County Counsel regularly provides those legal services, under some circumstances it is necessary or beneficial for the County to retain the services of a qualified private law firm to provide those services. County Counsel recommends retaining the firm Meyers/Nave for that purpose, within the two-year term and \$250,000 limit of this proposed contract. The County's excess insurer, CSAC-EIA, has confirmed that the reasonable costs of legal services by Outside Counsel in such matters will count toward satisfying the County's Self-Insured Retention.
