This resume is submitted to allow my qualifications to be considered for the Board of Trustees of the Goleta Library.

I received a BSEE from Rensselaer Polytechnic Institute in 1960. Married a local (Albany, NY) girl that I met there. My first job was designing hi-fi music consoles (pre-stereo) for Stromberg-Carlson in Rochester, NY. The company was sold to General Dynamics in 1961. Shortly afterward, the tails started falling off Convair 880 aircraft, and GD went into the submarine business (Electric Boat Division in Groton, CT). In the process, they fired 3,000 of us and shut down the division.

I decided I didn't want to work for a large company any more. (I figured it would be preferable to get fired for something I did, instead of something related to a division of the company that I had never heard of). So I joined the Ordnance Division of Clevite Corp (in Cleveland, OH), as an acoustical engineer. I went to school at night (MS Statistics from Case Western Reserve Univ. 1965) while heading the design team for the transducers and other acoustic subsystems of the Mk 48 Mod 1 ASW torpedo.

I did that for 14 years. During my time at Clevite, it was acquired by Gould Nat'l Battery, and the Ordnance division went from 76 employees to over 2,500. I left Gould in 1974 and joined the Sea Operations Department of Delco Electronics (General Motors) in Goleta, CA, as head of their Acoustics group (thus fulfilling my desire to work for a smaller company). Worked on several projects all involving underwater acoustics and long cables. We broke away from GM in 1982, bought the division we worked for and sold it to Science Applications Inc. in exchange for SAI stock.

The stock paid for the education of my children: Steve is a physician in Thousand Oaks CA; Erica leads the Microbiology Department at Colorado State University; and Robin works for an independent film distributor in San Francisco.

I founded my own company (Tech Associates LLC) and spent several years as a consultant to the governments of Japan and Republic of China and to a Goleta-based sonar manufacturing company Reson Inc. When the travel to Asia became too onerous I retired and served two terms on the County Grand Jury, where I became interested in local government and how it works (and sometimes doesn't). I also served as an elected Director of the Embarcadero Municipal Improvement District for 14 years.
