That the Board of Supervisors:

- a) Approve and authorize the Chair to execute Amendment No. 1 to the current Agreement for Services of Independent Contractor (BC-16-196) with the consulting firm Geo-Logic Associates, Inc. (not a local vendor), to provide construction quality assurance services for the Partial Final Closure Project (Phase 2 and 3) at the Tajiguas Sanitary Landfill, extending the contract term to December 31, 2019; and
- b) Find that pursuant to California Environmental Quality Act Guidelines Section 15162, no substantial changes are proposed, and no new information of substantial importance has come to light regarding environmental effects of the Tajiguas Sanitary Landfill Partial Final Closure Project (Phase 2 and 3) or of the sufficiency or feasibility of mitigation measures, and therefore the project and the approval of an amendment to an existing professional services agreement for the project is within the scope of the project covered by the Tajiguas Landfill Expansion Project EIR (01-EIR-05) certified by the Board of Supervisors on August 13, 2002, the Addendum to 01-EIR-05 dated November 8, 2006 and accepted by the Board of Supervisors on December 5, 2006 and the Tajiguas Landfill Reconfiguration and Baron Ranch Restoration Project Subsequent EIR (08-EIR-00000-00007) certified May 5, 2009.

Summary Text:

This item is on the agenda in order to consider an amendment to board contract (BC 16-196) with Geo-Logic Associates (not a local vendor) for construction quality assurance services related to the Tajiguas Sanitary Landfill Partial Final Closure Project (Phase 2 and 3). Construction quality assurance work related to the second phase of closure construction was completed per the original agreement. The third phase of landfill closure is schedule to be completed in the summer of 2019. This amendment extends the contract end date to December 31, 2019 to allow Geo-Logic Associates to continue providing construction quality assurance services for the third phase of landfill closure. The total contract amount remains unchanged.

Background:

Under the requirements of Title 27 California Code of Regulations, Class III municipal solid waste landfill facilities must prepare and file a written closure plan for the facility. A written closure plan was prepared by SWT Engineering, Inc. and is entitled "Phases 2 and 3 Partial Final Closure and Post-Closure Maintenance Plan and Phase 4 Preliminary Closure and Post-Closure Maintenance Plan for the Tajiguas Sanitary Landfill". The closure plan received approvals from the Central Coast Regional Water Quality Control Board in 2015 and California Department of Resources Recycling and Recovery in 2016. The closure project is divided into four phases. Phase 1 has been completed and a certification of the project was issued by Geo-Logic Associates, Inc. in 2010. Phase 2 construction was completed in summer of 2017 and is pending certification. Phase 3 is currently under construction, and will be completed in the summer of 2019. Phase 4 is scheduled to be completed in 2026.

Expansion, operation and phased closure of the Tajiguas landfill was analyzed in the Tajiguas Landfill Expansion EIR (01-EIR-05) certified by the Board of Supervisors on August 13, 2002. The Landfill environmental documents are available at http://countyofsb.org/pwd/environment.sbc. The Phase 3 closure includes a portion of the landfill front face and top deck which is visible from U.S. Highway 101. Pursuant to the mitigation requirements contained in 01-EIR-05, the closed landfill slopes will be contoured to be consistent with the surronding terrain, and hydroseeded with a native seed mix consistent with the surronding vegetation communities and compatible with the landfill cover system.

The Board authorized the Public Works Director to advertise for bids on the construction of the project on November 17, 2015.

The construction contract and associated construction management contract with Geo-Logic Associates was awarded on May 3, 2016.

The Resource Recovery and Waste Management Division Enterprise Fund will provide 100% of the project funding. Funding for this contract was approved in 2016; No additional funding is authorized as a part of this amendment.
