Recommended Actions:

That the Board of Supervisors considers the following:

- a) Approve and authorize the Public Health Department Director to appoint retired Environmental Health Specialist David Brummond as Extra Help, to provide Environmental Health Supervisory services limited to 160 hours for the Month of November 2018; and
- b) In accordance with California Government Code Section 7522.56(f)(1), certify that the appointment of retired County employee, David Brummond, is necessary to fill a critical need in the Environmental Health Division of the Public Health Department (PHD), before 180 days have passed from the date of retirement; and
- c) Determine that the above actions are organizational and administrative activities of government that are not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(5) of the CEQA Guidelines.

Summary Text:

This item is on the agenda to request the Board to allow retired Environmental Health Supervisor, David Brummond, be hired as Extra Help to assist with supervisor coverage during the Month of November 2018. Mr. Brummond retired in August 2018 from his position as an Environmental Health Supervisor in our Technical Services program with responsibilities that included drinking water, well construction, onsite sewage systems, solid waste, and land use. He retired with 32 years of service.

Background:

Since Mr. Brummond's retirement, the Public Health Department has initiated the process of hiring a replacement supervisor. Following his retirement, supervision of the respective services has fallen to Larry Fay, Environmental Health Director. Mr. Fay will be out of the office for several weeks in November and while it is expected that a replacement supervisor will be in place by November 1, the steep learning curve that he or she will face makes it highly desirable to have an experienced person to provide guidance in Mr. Fay's absence.

The Technical Services program provides regulatory oversight of solid waste facilities, well construction, onsite sewage system permitting, drinking water systems, and land use review. Most of the program's work is driven by customers. Timely review and decision making, the ability to clearly explain processes, and application deficiencies and corrections is critical in order to provide essential customer service. Mr. Brummond is extremely well versed in all aspects of this program.
