Consider amendments to the 2018 Board of Supervisors' Schedule of Meeting Dates and Locations as follows:

- a) Change the location of the December 4, 2018 meeting from Santa Barbara to Santa Maria and change the location of the December 11, 2018 meeting from Santa Maria to Santa Barbara; and
- b) Set a Special Meeting for Thursday, October 18, 2018, at 3:00 PM in Santa Barbara to consider acceptance of the California Coastal Commissions suggested modifications to the County Cannabis Ordinance Local Coastal Plan Amendment.

Summary Text:

In reviewing the 2018 Board meeting schedule during the weekly agenda review process, the Chair considered a request to switch the meeting location of the December 4, 2018 meeting from Santa Barbara to Santa Maria and to switch location of the December 11, 2018 meeting from Santa Maria to Santa Barbara. Approval of this request will maintain two meetings in the month of December with one each in Santa Maria and Santa Barbara.

In addition, staff is recommending that the Board of Supervisors set a special meeting for Thursday, October 18, 2018, at 3:00 PM in Santa Barbara to consider acceptance of the California Coastal Commissions suggested modifications to the County Cannabis Ordinance Local Coastal Plan Amendment. October 23, 2018 is a fourth Tuesday and not a scheduled meeting date, however, in order for the County to submit a timely response to the Coastal Commissions at their meeting of November 7-9, 2018, the County is not able to wait until the next scheduled Board of Supervisors meeting on November 6, 2108.

As such, staff is recommending that the Board of Supervisors amend the schedule of meeting dates and locations and schedule the December 4, 2018 meeting for Santa Maria and the December 11, 2018 meeting for Santa Barbara and, set a special meeting for Thursday, October 18, 2018, at 3:00 PM in Santa Barbara.
