Burke Corporation (a Tri-County Vendor), 865 Capitolio Way, San Luis Obispo, CA 93406, subject to the provision of documents and certifications, as set forth in the specifications applicable to the project, as required under California Law;
- c) Approve and authorize the Chair to execute the attached construction contract for the West Main Street Roadway Improvements, County Project 862403; Third Supervisorial District, which has been reviewed and approved by County Counsel, Auditor-Controller and Risk Manager, or their authorized representatives;
- d) Authorize the Director of Public Works or designee to approve change orders for a contingency amount up to \$23,642.30 plus an additional amount of \$10,000 for supplemental work items for the construction of West Main Street Roadway Improvements, County Project 862403; Third Supervisorial District, for a total not to exceed authorization of \$260,065.30; and

or no expansion of use beyond that previously existing, including but not limited to existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities), a Notice of Exemption was filed on that basis, and the proposed action is within the scope of the attached Notice of Exemption.

Summary Text:

This item is on the agenda to award a construction contract. On October 1, 2018, three (3) bids were opened for the West Main Street Roadway Improvements, County Project 862403; Third Supervisorial District. R. Burke Corporation submitted the lowest responsible bid in the amount of \$226,423, which is 8.0% higher than the Engineer's Estimate. The second lowest bid 12.7% higher than Engineer's Estimate.

This project was bid in accordance with the Public Contract Code, which requires the award go to the lowest responsible bidder. Public Works analyzed the bids and determined the low bid is responsive and responsible. Public Works recommends awarding this contract to R. Burke Corporation.

Background:

This project is part of the FY 17/18 RdMAP and is located on West Main Street, in the northeasternmost part of the County's right-of-way, west of the City of Guadalupe. Throughout the years, an average seasonal rain tends to flood this portion of the road. There have been previous drainage improvements to West Main Street east of this project, but this portion of the road has been slowly degrading from constant flooding and agricultural runoff. This area is relatively flat with minimal change in elevation, which contributes to pooling and flooding in low areas.

When seasonal flooding occurs in this area, County Maintenance closes the road, often for weeks at a time until enough water has infiltrated into the sandy shoulder. West Main Street serves as the only vehicle entrance point into the Rancho Guadalupe Dunes Reserve and during the road closure, public access cannot be maintained.

The proposed project includes removing failed asphalt and reestablishing the roadway profile to allow better drainage. This project will reestablish the width of the road to two ten-foot lanes, and a four-foot shoulder on either side. In addition, a two-foot deep v-ditch will be constructed on the south side of the road through the length of the project to maximize effectiveness against seasonal flooding. This v-ditch will drain into a larger existing culvert on the west side of the project limits.
