Recommended Actions: That the Board of Supervisors:

- A. Approve and authorize the Chair to execute the Agreement for Services of Independent Contractor with Health Management Associates (HMA) (a local vendor) to provide program and process evaluations of the Public Safety Realignment Act (AB109), with a total contract amount not to exceed \$44,500 (Attachment A);
- B. Authorize the Chief Probation Officer or designee to approve subsequent line-item budget changes to Attachment B-1 of each Agreement in an amount not to exceed 10% of the stated line-item budgeted amounts for each service, as long as the total contract amount of each Agreement is not increased, and as long as the total budgeted amounts by each funding source are not exceeded;
- C. Determine that the above actions are government fiscal activities or funding mechanisms which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment, and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to Section 15378(b)(4) of the CEQA guidelines.

Summary Text:

Health Management Associates (HMA) will evaluate the implementation of Public Safety Realignment (AB109) and make recommendations to the Community Corrections Partnership (CCP) and the local criminal justice system on strategies to improve local practices aimed at reducing recidivism for realigned offenders. To the extent possible, the evaluation will identify influential demographics, program elements, and intervention efforts that reduce recidivism and include actionable recommendations and priority areas for future treatment interventions and supervision strategies. The Agreement is funded through the 2011 Public Safety Realignment Act (AB109).

Background:

The Public Safety Realighment Act, Assembly Bill 109, transferred responsibility for specified lower level inmates and parolees from the California Department of Corrections and Rehabilitation (CDCR) to counties. This change was implemented on October 1, 2011. The Community Corrections Partnership (CCP) in each county is required to develop a Public Safety Realignment Act Plan for the subject population. Santa Barbara County's FY 2018-2019 Public Safety Realignment Act Plan, as developed by the CCP and endorsed by the Executive Committee of the CCP, was approved by the Board of Supervisors on May 15, 2018. A portion of this plan includes an outcome evaluation of the realigned population to guide and improve the County's collective practice. The evaluation will examine a variety of outcomes and variables related to recidivism.

Execution of the HMA agreement will provide an evaluation of local implementation and outcomes of Public Safety Realignment funded through AB109.
