Background:

On August 13, 2002, the BOS certified an Environmental Impact Report (EIR) (01-EIR-05) for, and approved, the Tajiguas Landfill Expansion Project (Front Canyon Expansion). An Addendum to 01-EIR-05 dated November 8, 2006 was accepted by the Board of Supervisors on December 5, 2006 In May 2009, the BOS certified a subsequent EIR (08EIR-00000-00007) for, and approved, the Tajiguas Landfill Reconfiguration and Baron Ranch Restoration Project (SCH No. 2008201052) (available for review at http://www.countyofsb.org/pwd/pwrrwm.aspx?id=3258).

The Tajiguas Sanitary Landfill Groundwater Protection System Phase 3C project is part of the Tajiguas Landfill Expansion and Reconfiguration Projects and is included Resource Recovery & Waste Management Division's (RRWMD) Waste Discharge Requirements issued by the California Regional Water Quality Control Board on February 4, 2010 and the Revised Solid Waste Facility Permit as issued on February 2, 2017. Phase 3C is included in the approved County of Santa Barbara 2016-2022 Five Year Capital Improvement Plan; Phase 3D was originally scheduled for construction at a later date; however, a portion of Phase 3D was completed in the fall of 2017. Pursuant to CEQA Guidelines Section 15162, no subsequent Environmental Impact Report or Negative Declaration is required for this project.

The Board's action to approve the Statement of Final Quantities is an administrative action necessary to determine the final payment to the contractor and will close the contract for the Phase 3C Groundwater Protection System.

Total construction costs, including supplemental work and contingencies came to \$2,491,991.13. The project was constructed within budget. Funds for this project were budgeted in Dept. 054, Fund 1930, Program 1750, and Account 8200.
