Justification: Project Rescue Flight, a non-profit organization, has recently approved the purchase of an upgraded search light that will improve and enhance the County Air Support

Units capabilities. This search light, once approved, will be installed in "Copter 2", one of the Air Support Unit's OH-58 helicopters.
