Budget Action: Incr appr. of \$10,300,800 in CSD/HCD Affordable Housing Fund for Services & Supplies (\$700,000), Other Financing Uses (\$165,000) and Increase to Restricted Fund Balance (\$9,435,800) funded by unanticipated revenue from Homeless Emergency Aid Program (HEAP) and CA Emergency Solutions & Housing (CESH) program. Increase of \$165,000 in CSD/HCD General Fund for Salaries & Benefits (\$145,000) and Services and Supplies (\$20,000) funded by an operating transfer from CSD/HCD

Justification: whereas the CESH application of \$914,745 was submitted September 2018. The HEAP grant runs for a two and a half year period beginning January 2019 through June 2021 whereas CESH has a maximum grant period of five years beginning January 2018 through December 2024. Both state grants require sub-recipients to participate in the Homeless Management Information System (HMIS) and the Coordinated Entry System (CES). The proposed grant funded positions will fund one FTE for HMIS & CESH sub-recipient agreements. Services Department (CSD) will be submitting a grant application to the CA Business, Consumer Services, and Housing Agency (BCSHA) for HEAP funds of \$9,385,186 California Emergency Solutions (CESH) program, in addition to two (2) full-time grant funded positions to assist in the administration.
