Title:

Recognize donation from Bertha Mae Christopher Living trust to Sheriff and Fire

Budget Action: Increase Appropriations of \$10,000 in Sheriff General Fund to increase Restricted Donations fund balance funded by Miscellaneous Revenue Other Donations. Establish Appropriation of \$10,000 in the Fire Department Fire Protection District Fund for Services and Supplies (\$10,000) funded by unanticipated revenue from Miscellaneous

Revenue (\$10,000).

Justification:

The Sheriff's Office and the Fire Department were granted \$10,000 each from the Bertha Mae Christopher Living Trust to be used in the Unincorporated Lompoc Area for Law Enforcement and Fire Services. The Sheriff's Office is placing the funds in a restricted fund balance until it is determined how the funds will be spent.

The Fire Department will use the funds to purchase and install "Opticom System" infrared traffic preemption devices in Fire Station 51 engines and ambulances. Traffic signals controlled with the "Opticom System" will change to green and provide right of way in the path of responding apparatus, using the latest in Global Positioning System (GPS) technology. This system will result in improved safety during emergency responses as well as reduced response times within the area. The department will work with the appropriate party to ensure that the intersection at the North end of H Street in Lompoc has the necessary "Opticom System" intersection equipment installed.
