### **Recommendations:**

That the Board of Supervisors authorize the Clerk of the Board to execute the attached Petition for Voluntary Merger of two County-owned properties (Assessor Parcel Number 004-047-017 and 004-047-002) into one parcel in connection with the Carpinteria Health Clinic Addition project # B12001/8626.

### Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 2 Ensure the Public Health and Safety and Provide Essential Infrastructure.

#### **Executive Summary and Discussion:**

These parcels are both owned by Santa Barbara County. They are located in the 900 Block between Maple and Walnut Avenues in Carpinteria. The Carpinteria Valley Museum of History is located on parcel 004-047-002, at 956 Maple Avenue, and the Veteran's Memorial Building, home of the Carpinteria Health Clinic, is located on parcel 004-047-017 on Walnut Avenue. An 835 square foot addition to the Veteran's Memorial Building is planned to allow expansion of the County Health Clinic.

The City of Carpinteria's review of our request for a Coastal Development Permit determined that the Veteran's Memorial Building exceeds the maximum allowable lot coverage of 40%. The proposed addition would exacerbate this problem by increasing the lot coverage to 43%. If the Memorial Building lot is merged with the Museum lot, the combined square footage of the two buildings, including the proposed addition, is

well under the maximum allowable coverage of the combined lots. The Carpinteria Planning Commission has accepted the proposed lot merger as a means to meet the lot coverage requirements associated with the Health Clinic addition.
