Budget Action: Increase Appropriations of \$72,000 in the Public Health Department Health Care Fund for Services and Supplies funded by unanticipated revenue from the California

Department of Public Health NEOP Branch.

Justification: This budget revision is necessary to increase appropriations in the amount of \$72,000 in the Public Health Department (PHD) Health Care Fund from supplemental

funding received from the CA Department of Public Health (CDPH) NEOP Branch. This increase in funding will cover a remodel of facilities to include space to prepare food for food demonstrations, new sub-contractors to provide program assistance, professional opportunities for school staff, policy systems changes at school campuses, and hosting of the Healthy Eating Active Living Community Summit. The total unanticipated funds is \$235,509.66 through September 30, 2017. However, it is anticipated by the program that the majority of this funding will be received in Fiscal Year 2017-18, as there have been some delays in planning for the new projects afforded by the funding. Therefore, this BRR will amend the Fiscal Year 2016-17 PHD Adopted Budget for an amount of \$72,000, which represents the anticipated amount of current year spending. Another Budget Revision for the rest of the funding, projected at \$163,509.66, will be brought to your board at the beginning of Fiscal
