Budget Action: Increase Appropriations of \$163,509 in the Public Health Department Health Care Fund for Services and Supplies funded by unanticipated revenue from the California

Department of Public Health NEOP Branch.

Justification: This budget revision is necessary to increase appropriations in the amount of \$163,509 in the Public Health Department (PHD) Health Care Fund from supplemental

funding received from the CA Department of Public Health (CDPH) NEOP Branch. The total unanticipated funds (\$235,509.66) for expenditure between June 2017 through September 30, 2017 was approved by the Board on June 6, 2017. However, a previous BRR (BJE-005031) was done for funding that was received in FY 2016-17 in the amount of \$72,000, and this BRR will amend the Fiscal Year 2017-18 PHD Adopted Budget for an amount of \$163,509, which represents the current year

spending.

This increase in funding will cover a remodel of facilities to include space to prepare food for food demonstrations, new sub-contractors to provide program assistance, professional opportunities for school staff, policy systems changes at school campuses, and hosting of the Healthy Eating Active Living Community Summit.
