- A. Whereas on July 3, 2018, the Board of Supervisors of the County of Santa Barbara approved an amendment to the County's Local Coastal Program by amending the Coastal Land Use Plan (Resolution No. 18-174, Case No. 17GPA-00000-00003) and by amending the Coastal Zoning Ordinance, Article II of Chapter 35, Zoning, of the County Code (Ordinance No. 5050, Case No. 18ORD-00000-00004), regarding the Highway 101: Carpinteria to Santa Barbara Local Coastal Program Amendment; and
- B. Whereas on August 14, 2018, the Board of Supervisors of the County of Santa Barbara reconsidered and reapproved Case No. 18ORD-00000-00004, which the Board adopted on July 3, 2018 to amend the Coastal Zoning Ordinance, Article II of Chapter 35, Zoning, of the County Code (Ordinance No. 5053, Case No. 18ORD-00000-00004) to include the Transportation Corridor Wetland Overlay District map as it relates to the Highway 101: Carpinteria to Santa Barbara Local Coastal Program Amendment; and
- C. Whereas on August 14, 2018, the Board of Supervisors of the County of Santa Barbara, by Resolution No. 18-199 submitted said amendment for consideration and certification to the California Coastal Commission; and
- D. Whereas on December 14, 2018, the California Coastal Commission approved a resolution of conditional certification with a suggested modification for this amendment to the County's Local Coastal Program (Coastal Commission Case No. LCP-4-STB-18-0071-2 Part A); and
- E. Whereas the Board of Supervisors finds the suggested modification to be acceptable.

NOW THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:

1. The above recitations are true and correct.

- 2. The Board of Supervisors acknowledges receipt of the California Coastal Commission's resolution of conditional certification with one suggested modification and accepts and agrees to the modification through amendment of the Coastal Land Use Plan as required in Section 13544(a) of the California Coastal Commission's Administrative Regulations and agrees to issue Coastal Development Permits for the total area included in the certified Local Coastal Program consistent with the suggested modification that the Coastal Commission certified.
- 3. The Board of Supervisors will submit this acknowledgment to the California Coastal Commission to demonstrate conformity with the provisions of the California Coastal Commission's action to certify the amendment to the Local Coastal Program in compliance with Section 13544(b) of the California Coastal Commission's Administrative Regulations.
- 4. The Chair of the Board of Supervisors is hereby authorized and directed to sign and certify all documents and other materials in accordance with this Resolution to reflect the above mentioned action by the Board of Supervisors.
- 5. The Board of Supervisors directs the Planning and Development Department to submit this Resolution to the Executive Director of the California Coastal Commission.
