That the Board of Supervisors:

- a) Approve and authorize the Chair to execute the attached Statement of Final Quantities for the Construction of Goleta Beach Park Bridge No. 51C-0358, (New Bridge No. 51C-0358, Old Bridge No. 51C-0158) over the Goleta Slough; County Project No. 862319 in the Second Supervisorial District for work performed and materials supplied by M.C.M. Construction, Inc., (not a local vendor), P.O. Box 620, North Highlands, CA 95660, in the amount of \$4,881,906.30; and
- b) Find that pursuant to State California Environmental Quality Act Guidelines Section 15162, no substantial changes were proposed, and no new information of substantial importance has come to light regarding environmental effects of the project or of the sufficiency or feasibility of mitigation measures, and therefore the proposed actions are within the scope of the Final Mitigated Negative Declaration (13NGD-00000-00018) and Mitigation Monitoring Program adopted by the Board on September 16, 2014, and therefore no new environmental document is required.

#### **Summary Text:**

This item is on the agenda to approve the attached Statement of Final Quantities. On June 21, 2016, your Board awarded the above referenced construction contract to M.C.M. Construction, Inc., and construction began on July 18, 2016. The Director of Public Works accepted this project as complete on April 5, 2018.

The new bridge replaced the existing bridge on a new alignment approximately 60 feet to the west of the existing bridge. The new bridge is a 168-foot long, two-span, cast in place concrete box Girder Bridge.

The new 53'6" wide bridge accommodates two 12-foot traffic lanes, two 4-foot shoulders, a 12-foot-wide Class 1 bicycle path and a 5 foot-wide sidewalk with barriers and railings separating bicycles and pedestrians from vehicles. The bridge has many aesthetic design features that enhance the park visitors experience and complements the surrounding environment. They include decorative bike railing, stained and stamped sidewalk that simulate a boardwalk. The concrete barriers are finished with faux cobble stone posts and wood grain beams.

#### **Background:**

The Goleta Beach Park Bridge spans the Goleta Slough and provides the only vehicle access to Goleta Beach Park. It also serves as a vital connection for the Coastal Route bike path across the slough to the park and continuing west to the University of California, Santa Barbara (UCSB).

The total construction cost, including contingencies, came to \$4,881,906.30. The Federal Highway Bridge Program (FHBP) funded \$4,321,951.65 (88.53%), and the California Toll Credit funded \$559,954.65 (11.47%). Funds for this project are budgeted in Fund 0017, Org Unit 0600, Program 2820, Department 054, Account 7510.
