- a) That the Board of Supervisors approves the attached proposed amendment to the Conflict of Interest Code of Vista Del Mar Union School District ("District"); and,
- b) Determine that the above action is an organizational or administrative activity of government that is not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(5) of the CEQA Guidelines.

Summary Text:

The District's Conflict of Interest Code amendments were adopted September 12, 2018. The amendments were done to include new positions, and non-substantive language changes in body. (See Attachment A-2018 Local Agency Biennial Notice; and Attachment B- District Resolution E 9270 dated September 12, 2018 with copy of amended Conflict of Interest Code, plus a Comparison Document showing track changes).

Background:

All public agencies are required by the Political Reform Act of 1974 to:

- 1. Adopt local conflict of interest codes identifying the reporting requirements of covered employees; and,
- 2. Review the need for any revisions to their local conflict of interest codes on a biennial basis.

The Political Reform Act designates Boards of Supervisors as the local Code Reviewing Body for independent districts and agencies. Government Code Section 82011. The revised Conflict of Interest Code is effective once approved by your Board. Government Code Section 87303.
