First Amendment to Agreement with Sanctuary Centers of Santa Barbara for

Recommended Actions:

That the Board of Supervisors:

- a) Approve, authorize, and ratify the Chair to execute a First Amendment to Agreement for Services of Independent Contractor with Sanctuary Centers of Santa Barbara (a not-for-profit organization) to provide program delivery services targeted towards medium - high risk inmates incarcerated at the Santa Barbara County Jail for the period of January 01, 2019 to June 30, 2019.
- b) Find that the proposed actions do not constitute a "Project" within the meaning of the California Environmental Quality Act (CEQA), pursuant to 14 CCR 15378(b)(5), in that they are government administrative activities that will not result in direct or indirect changes to the environment.

Summary Text: Sanctuary Centers of Santa Barbara will continue to provide counseling services such as, but not limited to individual screening and assessment, intake, brief case management, brief individual counseling, facilitation of evidence based correctional groups, discharge planning and coordination of discharge services with the countywide discharge planning team. However, the bulk of the time spent shall be on facilitating and teaching cognitive behavioral training programs in-group settings.

Background:

On January 9, 2018, the Sheriff's Office entered into a contract (attachment B) with Sanctuary Centers of Santa Barbara in order to broaden programming and provide intensive and appropriate services to all higher risk populations. The contract was effective January 1, 2018 to December 31, 2018. This is the first request for an extension. The Community Corrections Partnership (CCP) has provided funding to contract these services. Contracted services will be expanded to deliver other evidence-based learning and rehabilitation opportunities for inmates in the Santa Barbara County Jail. This expansion will increase the delivery of targeted Cognitive Behavioral Therapy interventions, as proven most effective in reducing the recidivism of the communities most costly criminal offenders. The extension period is six-months in anticipation of conducting a review of the current period by June 30, 3019.

Funding for this contract is provided by the Community Corrections Partnership in the FY 2017-2018 Realignment Plan. A total of \$44,992.70 of the original contract's \$134,978.00 not-to-exceed amount was paid on the original approved contract that ended on December 31, 2018. With this extension, there will be \$89,995.30 of the not-to-exceed amount remaining.
