<b>Project Description:</b> The project replaces a 22-foot long and 8-foot wide non-vehicular bridge on the East Valley Road Trail and repairs portions of two (2) stone bridges on the Ennisbrook Trail, each approximately 13 feet wide and 45 feet in length. The East Valley Road Bridge was destroyed and the Ennisbrook Trail stone bridges and embankment were damaged during the January 2018 storm event (4353-DR). Civil engineering is required in order to implement proper replacements and repairs in order to bridge the East Valley Road Trail and the Ennisbrook Trail back to operable condition.
