FIRST AMENDMENT FY 2017-2020

TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

This is an amendment (hereafter referred to as the "First Amended Contract") to the Agreement for Services of Independent Contractor, referenced as number <u>BC 18-192</u>, by and between the **County of Santa Barbara** (County) and **The University Corporation**, a **California corporation** (Contractor), for the continued provision of services specified herein.

Whereas, this First Amended Contract incorporates the terms and conditions set forth in the contract approved by the County Board of Supervisors on March 20, 2018, except as modified by this First Amended Contract.

Whereas, the Contractor will provide a greater number of services than contemplated by the original Agreement and will incur expenses beyond the value of the original Agreement. This amendment adds additional funds up to \$24,766 for Fiscal Years 18-20, for a new multiyear Agreement maximum not to exceed **\$224,766** so as to compensate Contractor for additional services to be rendered under this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

- I. In the Agreement Section 4. Term, delete Section 4 and replace with the following:
 - 4. Term.

Contractor shall commence performance on 3/1/2018 and end performance upon completion, but no later than 8/31/2019 unless otherwise directed by County or unless earlier terminated.

- II. Add to Exhibit A Scope of Work, Section 3 Services, as subdivision B(ii)(d) the following:
 - (d) Each County may request one additional training for additional staff, which shall be limited to a two (2) hour training workshop on cultural competency per SCRP provider.
- III. Delete Section I. of Exhibit B, Financial Provisions, and replace with the following:
 - 1. **CONTRACTOR SERVICES**. For services to be rendered under this Agreement, Contractor shall be paid at the rate specified in the Schedule of Rates (Exhibit B-1), with a maximum value not to exceed \$224,766 through August 31, 2019.
- IV. <u>Delete Exhibit B-1, Schedule of Fees</u> and replace with the following:
