The Agreement is amended as follows:

1. Section 4, TERM, of the Agreement is amended to state in its entirety:

CONTRACTOR shall commence performance on March 13, 2018 and end performance upon completion, but no later than *July 31, 2019*, unless otherwise directed by COUNTY or unless earlier terminated.

In all other respects, the Agreement remains unchanged and shall remain in full effect.
