WITH REFERENCE TO THE FOLLOWING:

- A. Whereas, the County of Santa Barbara (County) received an application (15LLA-00000-00003) for a lot line adjustment on contracted land which resulted in the need for two replacement land conservation contracts and establishment of two new agricultural preserves;
- B. Whereas, the new preserve created by this Resolution consists of 322.7 acres located approximately 2,800 yards northwest of the intersection of Highway 246 and Cebada Canyon Road, in the Lompoc area (APN 099-090-003 and a portion of APN 099-090-013);
- C. Whereas, a portion of the new preserve area was previously covered under preserve 69AP047;
- D. Whereas, this matter was considered by the County's Agricultural Preserve Advisory Committee on March 4, 2016 and February 1, 2019, and this new preserve is being created following a hearing of the Board of Supervisors on May 7, 2019; and
- E. Whereas, notice of these actions have been provided as required by law.

IT IS HEREBY RESOLVED AS FOLLOWS:

- 1. The above recitations are true and correct.
- Pursuant to the California Land Conservation Act of 1965 (the Williamson Act), (Government Code Sections 51200 et seq.), The Wagner Preserve for Lot 1 of Lot Line Adjustment 15LLA-00000-00003 (16AGP-00000-00037) is hereby established as an Agricultural Preserve in the County of Santa Barbara, is hereby entered into.
- 3. A map of the preserve is filed in the Office of the Santa Barbara County Surveyor, and the preserve land is described in Exhibit "A" attached to the Short Form Land Conservation Contract.
- This agricultural preserve shall be administered pursuant to the California Land Conservation Act of 1965 and the Uniform Rules for Agricultural Preserves and Farmland Security Zones adopted by this Board pursuant to said Williamson Act.
- 6. Based on Uniform Rule 1-3, the contract 69AP047 is hereby rescinded and replaced by contracts 16AGP-00000-00037 and 16AGP-00000-00038;
- 5. The Clerk of the Board shall endorse the fact of this adoption and the date thereof on said Surveyor map and shall record this Short Form Land Conservation Contract (Short Form Contract) with description attached at the Office of the Santa Barbara County Recorder. In addition, the Clerk of the Board shall forward to the following interested parties copies of documents as follows:
 - i. To the County Recorder, a copy of the Surveyor's map;
 - ii. To the property owner, a duplicate original copy of the Short Form Contract, a certified copy of this Resolution, and a copy of the Surveyor's map;
 - iii. To the Planning and Development Department, a conformed copy of the Short Form Contract, a certified copy of this Resolution, and a copy of the Surveyor's map;

- iv. To the Assessor, a certified copy of the Short Form Contract, a certified copy of this Resolution, and a copy of the Surveyor's map; and
- v. To the Surveyor, a certified copy of the Short Form Contract.
