#### **Recommended Actions:**

That the Board of Supervisors:

- a) Approve, ratify and authorize the Chair to execute the First Amendment to the Agreement with KRA Corporation (not a local vendor) for One Stop Operator and Adult and Dislocated Worker Program Operator Services in Santa Barbara North County to revise the total contract amount not to exceed \$1,776,661 (Fiscal Year 2016/2017 for \$339,471; Fiscal Year 2017/2018 for \$673,716; and Fiscal Year 2018/2019 for \$763,474);
- b) Approve, ratify and authorize the Chair to execute the Second Amendment to the Agreement with KRA Corporation (not a local vendor) for One Stop Operator and Adult and Dislocated Worker Program Operator Services in Santa Barbara South County to revise the total contract amount not to exceed \$1,426,905 (Fiscal Year 2016/2017 for \$252,439; Fiscal Year 2017/2018 for \$396,057; and Fiscal Year 2018/2019 for \$778,409);
- c) Authorize the Director of Social Services or designee to adjust the Line Item Budget in Exhibit B-1 Revised of the KRA Corporation for One Stop Operator and Adult and Dislocated Worker

- Program Operator Services in Santa Barbara North County Agreement, and the Line item Budget B-1 Revised (1/2019) and Exhibit B-2 Wildfire NDWG Revised of the KRA Corporation for One Stop Operator and Adult and Dislocated Worker Program Operator Services in Santa Barbara South County Agreement, without exceeding the total contract amount; and
- d) Determine that the approval and execution of the Budget Revision Request and Amendments are not the approval of a project that is subject to environmental review under the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines section 15378(b)(4) and (b)(5), finding that the project is a creation of a governmental funding mechanism or other government fiscal activity, which does not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment, and finding that the activity is not a "project" since the activity is an organizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment.

#### **Summary Text:**

These items are on the agenda in order to approve and ratify the Second Amendment to the Agreement with KRA Corporation (KRA) in Santa Barbara North County to decrease the total contract amount for Fiscal Year (FY) 2017/2018 for the period of July 1, 2017, through June 30, 2018, and increase the total contract amount for FY 2018/2019 for the period of July 1, 2018, through June 30, 2019; and to approve and ratify the Second Amendment to the Agreement with KRA in Santa Barbara South County to decrease the total contract amount for FY 2017/2018 for the period of July 1, 2017, through June 30, 2018, and increase the total contract amount for FY 2018/2019 for the period of July 1, 2018, through June 30, 2019. Additionally the Amendments update performance goals and amend contract language to allow for budget variances. This facilitates KRA's ability to minimize any disruption in services to clients and maximize funding for training plans that extend through fiscal years. In no event shall the overall budget amount be exceeded without a formal amendment to the Agreement.

#### **Background:**

The Workforce Innovation and Opportunity Act (WIOA) was signed into law on July 22, 2014. It repeals the Workforce Investment Act of 1998 and replaces it with new authorization language that is in effect from July 1, 2015 through June 30, 2020.

KRA is the current One Stop Operator and Adult and Dislocated Worker Program Operator Services in Santa Barbara North and South County fulfilling the purpose and intent of the WIOA; and helping businesses, individuals, and industries achieve and sustain economic vitality across all communities in Santa Barbara County.

**Performance Measure:** The following performance measures remain for KRA:

- 1. Enroll 494 unduplicated participants in North County and 329 unduplicated participants in South County over the term of the Agreements.
- 2. Enroll the following number of Adult and Dislocated Workers (DW) participants in the North and South County:
